Greetings from your World Service Office! In the course of review of several matters pertaining to the Al-Anon telephone meetings on the 712-432-8733 number/access code 52639, a meeting with [REDACTED]

(confidential WSO names), was held last week. We commend you on your plan to improve security for the meetings held on this phone line. We reviewed the documents posted on the phone line Web site, and noted that you have provided a clear plan, that allows each individual meeting to choose (or not) to have a security monitor to be sure that any disruption to that meeting is handled immediately.

We must bring your attention to another matter that came to light in the staff meeting. We regret to inform you that during our discussion we realized that the WSO has not enforced its own policy on a matter directly relating to the phone meeting Web site, [www.alanonphonemeetings.org](http://www.alanonphonemeetings.org). Only Al-Anon service arms can use the Al-Anon name (with or without the hyphen) in a URL or on a Web site. As you know, the phone line ("bridge") on which the meetings are held is not an Al-Anon service arm; it is most similar to a clubhouse, which is an outside entity that may provide a meeting location for Al-Anon and other 12-Step programs. Though we have been corresponding with you and other trusted servants about the Web site for several years, this basic fact was overlooked. So we must ask that you transfer the URL [www.alanonphonemeetings.org](http://www.alanonphonemeetings.org) to Al-Anon Family Group Headquarters, Inc. When the transfer is complete, the WSO will direct that URL to the electronic meeting list on our Web site.

We appreciate your cooperation in taking care of this matter. To give you time to set up a Web site for posting of meeting formats and other phone line business with a new URL that does not include the name Al-Anon (or alanon), we ask that the transfer be completed by August 30, 2014. We are happy to have you link your new Web site to the WSO list of telephone meetings, or other appropriate pages on the WSO Web site.

We thank you for your prompt attention to this matter, and for all the service you provide.
